



**Montgomery County Animal Shelter
Asilomar Accords Report
for
04/01/2019 to 04/30/2019**

The Asilomar Accords is a set of criteria developed in 2004 to be used by animal shelters across the nation. This criterion serves as guiding principles, standardized definitions and a statistics table for tracking shelter populations including foster care and a formula for determining a live release rate.

From April 01, 2019 to April 30, 2019, the Live Release Rate for the Montgomery County Animal Shelter was: 94.8%.

The Live Release Rate does not include 21 animals who's owner/guardian requested euthanasia which were unhealthy and untreatable (see line R) and 31 animals that died or were missing, lost or stolen in shelter or foster care (see line U).

Beginning Shelter and Ending Shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.

Every animal that was saved was a direct result of caring, compassionate and dedicated Fosters, Volunteers, Rescue Organizations, Adopters, Staff and Veterinarians working together.

For the voiceless animals we say "THANK YOU for CARING".
