



**Montgomery County Animal Services  
Asilomar Accords Report  
for  
09/01/2022 to 09/30/2022**

**The Asilomar Accords is a set of criteria developed in 2004 to be used by animal shelters across the nation. This criterion serves as guiding principles, standardized definitions and a statistics table for tracking shelter populations including foster care and a formula for determining a live release rate.**

**From September 01, 2022 to September 30, 2022, the Live Release Rate for the Montgomery County Animal Shelter was: 96.5%.**

**The Live Release Rate does not include 0 animals who's owner/guardian requested euthanasia which were unhealthy and untreatable (see line R) and 9 animals that died or were missing, lost or stolen in shelter or foster care (see line U).**

**Beginning Shelter and Ending Shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.**

**Every animal that was saved was a direct result of caring, compassionate and dedicated Fosters, Volunteers, Rescue Organizations, Adopters, Staff and Veterinarians working together.**
